Basic Parliamentary Procedure

District Constitution By-Law I	In order to expedite the work of the District Conference, it shall be governed by a spirit of Christian love and fellowship, and by the ac- cepted rules of parliamentary procedure as outlined in Robert's Rules of Order.
Membership	Participation in Conference business shall be limited to those holding active credentials with the Quebec District of The Pentecostal Assem- blies of Canada, except for those who hold Ministry Related creden- tial, and lay delegates with a current letter from the delegates' church so identifying him or her as an official representative. All members of the Conference must register with the Roster Committee.
Conference Bar	All members participating in the Conference business must do so from within the Conference Bar as determined by resolution of this Conference.
Addressing the Chair	All members speaking to the Conference must direct their remarks to the Chair. After standing and addressing the Chairman, the member shall wait to be recognized by the Chair before proceeding to speak. Dialogue on the Conference floor is not permitted.
Speaking to a Motion	When speaking to a motion, a member is expected to complete their remarks and then refrain from speaking again to the same motion until all others who so wish may do so
Alternate Speakers	After one member has spoken to a motion, the same motion should not be spoken to by another speaker until opportunity has been made for a member to speak in opposition to the motion, if there should be such.
Punctuality	Members of the Conference are requested to be in their chosen places within the Bar at the commencement of the session. Moving in and out of the Bar is distracting and should be avoided.
Announcements	All public announcements must be submitted to the Conference Secretary in writing. All such announcements must be made from the rostrum.

Minutes of the 2021 District Conference

Twelfth District Conference Virtual / Zoom May 11, 2021

1.1 Welcome and Instructions

The Secretary-Treasurer, Reverend John Ippolito, welcomed everyone to the Twelfth District Conference. He mentioned that exceptionally this session will be conducted by Zoom and that it will be bilingual. He then gave some practical guidelines regarding the Zoom platform.

1.2 Prayer

The Secretary-Treasurer prayed for this conference and especially for the needs of the following people: Michael Dukefe, Don Mann, David Hazzard, and Sylvie Lemoyne-Bisaillon. He then turned the floor over to the Superintendent who shared what God has put on his heart.

1.3 Acknowledgements and System Instructions

The Secretary-Treasurer first thanked the Superintendent for his message of encouragement and Rev. Anne Yank for the translation as well as Anne-Marie Lawrence and her team for the worship song. He then gave instructions for the Zoom chat, the voting system and translation for those who needed it.

1.4 Call to Order

The Chairman called the business session of the Twelfth District Conference to order at 10:15 a.m. He advised that anyone wishing to speak during the session should do so via the "chat" option.

He then proposed the first 8 motions that were seconded by those in attendance, and a vote was taken via the *Simple Vote* system.

1.4.1 Motion 1 : Voting Bar

He moved that the voting bar be designated by those registered and eligible voters who received the first ballot at their SINGLE email address submitted.

1.4.2 Motion 2 : Ratification of candidates for accreditation from 2019-2021

He moved that the list of candidates for accreditation listed in the Conference booklet on **pages 53-54** *and adopted by the Leadership Team, be accepted by the floor.*

1.4.3 Motion 3 : Roster Committee Report

He invites Reverend John Ippolito to show the Roster report on the screen.

The Secretary-Treasurer moved that the Roster report be received.

1.4.4 Motion 4 : Voting Privilege

He moved that the privilege of voting be granted to Rev. Anne Yank (credential holder in the Eastern Ontario District) and Rev. David Hazzard of the International Office. Reverend David Wells, General Superintendent, is recognized ex officio as a voting member of the District.

1.4.5 Motion 5 : Conference Committees

He moved that the following committees be adopted: Parliamentary and Resolutions, Roster Committee, Minutes Committee and Scrutineers, as listed in your Conference booklet on **page 55**.

1.4.6 Motion 6 : Conference Schedule

He moved the adoption of the 2021 Conference schedule, found on page 3 of your Conference booklet.

1.4.7 Motion 7 : Adoption of the 2019 District Conference Minutes

He moved to adopt the minutes of the Eleventh Quebec District Conference, May 27-29, 2019, mailed and included in the Conference booklet on **pages 43-50**.

1.4.8 Motion 8 : Receipt of the Written Reports in the Conference Booklet

He mentioned that the verbal reports will not be received as such and that no vote of acceptance will be taken.

1.5 Voting for Motions 1-8

We will move on and vote on motions 1 through 8 by *Simple Vote*. There is a 3-minute voting period before closing.

1.6 Voting Results for Motions 1-8 of 1.5

1.7 Introduction of Lay Delegates

The President welcomed all the Lay Delegates who are present at this virtual 2021 Conference.

1.8 Voting for the Resolution regarding Amendments to the District Constitution

The President invited Reverend Gary Connors, Chairman of the Resolutions Committee, to present the resolution that everyone had received in the mail and which is in the Conference booklet on **pages 51-52**.

Reverend Connors moved that Resolution Number 1 "Proposed Amendments to the District of Quebec Constitution and Bylaws" be adopted.

This resolution was moved and seconded by those present.

We will now proceed to vote. There is a 3-minute voting period before closing.

1.9 Result of Voting on Resolution of 1.8

The result of the voting is shown on the screens:

1.10 Change of Chair

The President invited Reverend John Ippolito to take the chair.

1.11 Presentation of the Superintendent's Report and Thanks

Reverend John Ippolito invited delegates to email questions directly to the officers or personally to the Superintendent. He then thanked the Superintendent for his report.

1.12 Presentation of the Superintendent's Pre-Conference Vote by Mail

Reverend John Ippolito invited Reverend Paul Tétreault to read By-law 3 of the District Constitution regarding the nomination of the Superintendent. 3.3.1.1 A pre-conference ballot for the position of District Superintendent shall be mailed 60 days prior to District Conference to all members eligible to vote at District Conference, as described in Article VIII, Sections 2 and 3, to be returned postmarked no later than 30 days prior to District Conference. The pre-conference nomination ballot shall be mailed together with a description of the qualifications, responsibilities and duties of the Superintendent and the District Leadership Team.

3.3.1.2 At a meeting of the District Leadership Team, no later than three months prior to the District Conference, the District Leadership Team shall appoint a Nominations Committee of three members. The members of the Nominations Committee shall declare themselves to be non-candidates.

3.3.1.8 In the event that a standing candidate receives the required two-thirds nominations on the pre-conference nomination ballot, a ratification vote shall be conducted at the District Conference, and a simple majority vote shall constitute election on this ratification ballot.

The results of the pre-conference nomination ballots are shown on the screen. It was 91%, so we proceed to the ratification vote.

1.13 Superintendent Ratification Vote

The President invited the delegates to vote. A 3 minute voting period is allowed before closing.

1.14 Result of the Superintendent Ratification Vote of 1.13

1.15 Change of Chair

The President invited Reverend Michel Bisaillon to take the Chair.

1.16 Presentation of the Assistant to the Superintendent's Report

The President invited the team to share the Assistant to the Superintendent's report, which was pre-recorded at the District of Quebec offices.

The President thanked Reverend Paul Tétreault for his report. If there are any questions, he invited the delegates to communicate them by e-mail directly to the officers or personally to Reverend Tétreault.

1.17 Presentation of the name to the position of Assistant to the Superintendent

The President read District Constitution Policy 3.4.1.1 regarding the nomination of the Assistant to the Superintendent.

3.4.1.1 The Assistant to the Superintendent shall be elected by the District Conference after at least one name has been presented in nomination to the Conference by the District Leadership Team, with further nominations accepted from the floor in a nominating ballot. All votes shall be publicly recorded.

The Leadership Team presented the name of Reverend Paul Tétreault for the position of Assistant to the Superintendent. The list of eligible ordained candidates can be found on **page 55** in the Conference booklet.

1.18 Assistant to the Superintendent - Nomination Vote

The President invited the delegates to vote. A 3-minute voting period is allowed before closing.

1.19 Presentation of the Secretary-Treasurer's Report

The President invited the team to present the Secretary-Treasurer's report, which was pre-recorded at the District of Quebec offices.

The President thanked Reverend John Ippolito for his report. If there are any questions, he invited the delegates to email them directly to the officers or personally to Reverend Ippolito.

1.20 Result of the Assistant to the Superintendent's vote (2/3 vote) of 1.18

The results of the Assistant to the Superintendent's vote are displayed on the screen.

1.22 Result of Pre-Conference Nomination of Members-at-Large (done by District Officers and Pastoral College)

The President read By-Law 3 of the District Constitution regarding the nomination of the Members-at-Large.

3.1.3.1 The Sectional Pastors and District Officers shall form a nominating committee to place a minimum of six and no more than nine candidates in nomination to the District Conference for the positions of the three District Leadership Team Members at Large.

3.1.3.2 From the slate of nominees three Members at Large shall be elected by the District Conference to serve on the District Leadership Team. A simple majority and a plurality of votes are required for election on any election ballot. Should all positions not be filled on the first election ballot, then the candidates with a simple majority would be considered elected and the name receiving the lowest number of votes shall be dropped on this and any subsequent ballots until all the positions are filled.

1.23 Vote # 1 - Ballots for Members-at-Large

The President invited the delegates to vote. A 3-minute voting period is allowed before closing.

1.24 Presentation of the Institut biblique du Québec report

The President invited the team to present the report of the President of IBQ, Reverend Jonathan Bersot, pre-recorded directly from Togo.

The President thanked Reverend Jonathan Bersot for his report.

1.25 Result of vote #1 for Members-at-Large of 1.23

The President invited the team to present the result of the vote. The result is displayed on the screen.

The names of Reverend **Gary Connors**, Reverend **Patrick St. Onge** and Reverend **Ron Rust** were selected by the District Leadership Team.

The President invited the congregation to nominate other ordained ministers, if desired. The names are in your Conference booklet on **page 57**.

1.27 Nomination vote for the General Executive Board

The President specified that only one name must be on the ballot and that if other names are chosen, the names with more than 5% will be retained for the election vote. Whoever receives more than 2/3 in this vote will be elected.

The President invited the delegates to vote. A 3-minute period is allowed for voting before closing the vote.

1.28 Presentation of the International Office's reports

The President invited Reverend David Wells, Reverend David Hazzard and Reverend Murray Cornelius to present the prerecorded reports of the National Officers.

He thanked them for their reports.

1.29 Result of the nomination vote for the General Executive Board (Election by a 2/3 majority) of 1.27 The President invited the Secretary-Treasurer to present the results of the vote displayed on the screen.

3.9.2 Qualifications

3.9.2.1 The section pastors shall be credential holders of mature experience, sound character and recognized ability, who are either ordained, or have been credentialed for a period of not less than five consecutive years with The Pentecostal Assemblies of Canada. They must have served at least one year in the Québec District immediately prior to election.

3.9.3 Nominations & Elections

3.9.3.2 Each section shall conduct a nomination vote. Each eligible voter, as described in Article VIII, Section 2 and 3, shall be eligible to cast a nomination ballot for a section pastor for his or her respective section. This vote shall take place no less than 30 day prior to the District Conference.

3.9.3.3 From the nomination ballot, the candidates receiving the two highest numbers of votes shall form an election ballot that shall be presented at the District Conference to all eligible voters. The person receiving the highest number of votes shall be declared elected.

3.9.3.4 The term of office for the section pastors shall be two years.

11. CONTROLLED NOT-FOR-PROFIT ORGANIZATION

The Québec District of the Pentecostal Assemblies of Canada (the District) controls the Institut Biblique du Québec (the Institute) by virtue of its ability to influence the strategic and operational aspects of this Organization.

Institut Biblique du Québec

The Institute was established to provide theological education and pastoral training. The Institute is incorporated under Part 3 of the Quebec Companies Act and is recognized as a registered charity under the Income Tax Act. During the year, the Institute used premises owned by the District and contributed \$75,000 (2021 - \$75,000) towards the operating costs of the premises. The Institute also received subsidies from the District of \$nil (2021 - \$351,900). The Institute follows the accrual basis of accounting and has not been consolidated in the District's financial statements.
